

**CONTRACT FOR PROFESSIONAL DISC JOCKEY MIXING AND RECORDING SERVICES**

Failure to pay the balance due on the date of the event to DJ will subject Client to a \$50.00 late fee plus interest at the rate of 10% per week on the unpaid amount. In consideration for the services provided, Client agrees to pay DJ a total fee of \$ \_\_\_\_\_ by check, or by cash.

This Contract constitutes the entire understanding between the parties, and there are not covenants, promises, representations, or warranties other than as set forth herein. No modification of its terms will be valid unless they are recorded in a written instrument signed by both parties. In the event any provision of this agreement is determined to be invalid or unenforceable, the remaining provisions will remain in full force and effect. This contract will be interpreted according to the laws of the state of Colorado, and jurisdiction and venue will be deemed to be proper in Pueblo County, Colorado. In the event of breach of Contract, a court may award attorney fees, court cost and related expenses to the prevailing party.
